# 2021: HONOURS DEMI-HOURS REGISTRATION PROGRAMME: LETTER OF AGREEMENT

### PURPOSE

The purpose of this agreement is to outline the scope of the Honours Demi-Hour Registration Option that students will be required to agree to in writing.

### PREAMBLE

For the Honours Degree in Visual Communication, the Open Window offers two registration options, namely a Standard Registration and a Demi-Hour Registration.

'Demi-hours' refers to the mandatory 250 hours required of the student to work for Open Window, should the 'Honours Demi-Hour Registration Option' be selected.

### Standard Honours Registration

The 'Standard Honours Registration' refers to an Honours registration where the student is liable to pay in full, per credit. The per credit rate is R842.50 amounting to a standard fee of R101 100 for the Honours programme.

## Demi-hour Honours Registration

Open Window also markets the 'Demi-hour Honours Registration' option, in keeping with the national imperative of widening admission access to tertiary education and promoting equity in higher education programmes by offering a fee reduction in return for 'worked hours' at Open Window. This option may not only alleviate the financial strain of the Standard Registration Programme, but furthermore, provides the opportunity to the student to gain work experience. The discount of R28 300 is calculated based on the monetary value of 1 demi-hour amounting to R113.20.

The 'Demi-hour Honours Registration' option costs R72 800 (the credit rate remains the same, with a total R28 300 discount applied as a maximum).

The student is provided a discount of R28 300 (calculated at a rate of R113.20 per hour worked). The student is then required to work 250 hours at Open Window to total the discounted rate in the same academic year.

'Demi-hours Honours Registration' refers to the optional registration programme where a student is able to work 250 hours for Open Window, thus receiving a 'work-return' discount off the Honours programme.

The Demi-hour registration option works out to a fee reduction of R28 300(R113.20 per hour, for 250 hours worked). These hours are mandatory and part of the registration package on the demi-hour option.

#### **TERMS OF AGREEMENT**

Students that have registered on the Demi-Hour option, are able to begin working towards completing their demi-hours from the start of the academic year and will be required to complete their demi-hours 8 weeks before graduation as indicated in the academic calendar (the dated terms of agreement are outlined below). Students with incomplete hours at the end of the term will be invoiced for the outstanding hours at R104,80 per hour as indicated above. Open Window has the right to withhold graduation should the student not have completed the hours and/or paid for hours outstanding as per any remaining outstanding fees.

- 3. Exam invigilation
- 4. Festivals & events
- 5. OW marketing & Awareness Campaigns
- 6. OW magazine publication
- 7. Studio assistants & lecturing assistants
- 8. Tutoring & undergrad mentoring
- 9. Other
